 - a. 2016 Closeout Report Anita Atkinson
 - i. 45 Scholarships Awarded; \$80K (\$28.5K from endowments
 - ii. Cost of banquet \$6469; \$3500 from banquet sponsors.
 - b. New Tax Preparation Firm: McClellan & Associates CPAs, LLC Roseana Richards
 - i. Roseana suggested trying new preparer. Current preparer adequate, but slow and consistently have to rework. Good initial interview with new firm. As administrative item and coordination with John Boneberg, agreed to try new firm for this year's filing.
 - c. 2015 Draft Tax Return Anita Atkinson New Firm already has draft. Very responsive. Roseana and Anita to review differences between filings and proceed.
 - d. Tax Form 990 Issues: Additional Bylaws: John Boneberg/Roseana Richards: New accounting firm raised question based on filing regarding non-profit provisions that are identified in tax filing. Presently, GEF does not have some policies in place. Absence of these policies may raise flags with tax filing. Specifically:
 - i. Form 990 Page 6 question 12a Conflict of Interest Policy
 - ii. Form 990 Page 6 question 13 Whistleblower policy
 - iii. Form 990 Page 6 question 14 Document Retention and Destruction Policy
 - iv. Dissolution clause

After disdcussion, John Boneberg made suggestion that a Subcommittee be formed to review the need of these policies and to draft policies for Board Review. Roseana made motion and Beth Harris second. Passed board vote unanimously.

- e. 2017 Membership Dues in February John Boneberg: Reported that membership dues typically go out in February. May need to coordinate with communication of opening of application period (see below).
- 4. Scholarship Committee Report: John Boneberg
 - i. Web Rebuild/Online Application Process John Boneberg; Boneberg reported current on line process not sustainable and web site in desparate need for rebuild. Suggested that research firms to complete both web site rebuild and re-do application process. May impact opening of application period based on time to complete rebuild. Suggested that Board be form subcommittee to research qualified firms and costs. Identified a subcommittee of Jimmy Crowder, Theresa Brunasso, Julie Secrist and John Boneberg. Suggested Board be prepared to delay opening to July 1 to give time to complete. Still Close August 31 and award per normal schedule if possible. Beth made motion in support of Boneberg suggestion.
